



FAMILY UNIT CERTIFICATION FORM

Family Membership

Adult family members have the opportunity to join Lions, as a family, and receive reduced international dues and charter/entrance fee relief. The first family member (head of household) pays the initial charter/entrance fee and full international dues. Up to four subsequent qualifying family members pay half international dues and no association charter/entrance fee.

To apply, complete this form and submit with the club charter application or MMR. Or, complete certification using the WMMR.

For the purpose of LCI's family membership dues rate, eligible families shall be defined as:

All members living in the same household related by birth, marriage or adoption. Such common family relations include parents, children, spouses, aunts/uncles, cousins, grandparents, in-laws and other legal dependents.

Family membership is limited to no more than five qualifying members per household (above the age of majority) and new clubs must have a minimum of ten (10) full paying members. Membership in the same Lions club and proof of same household residency is required. For family members under age 26, residency in the same household is not required if pursuing higher education or serving in their country's military service.

Certifying Family Members

The district governor, guiding Lion or club secretary is responsible for reviewing original documents provided by a family unit (proof of relations and household address) to determine if they satisfy the family membership dues requirements. All information requested must be provided, including date of birth, or certification will be delayed. Please use the key codes, provided below, to facilitate accurate and consistent reporting of 1) relationship to the head of household, 2) document used for relationship verification and 3) document used for address verification.
